## Review of Community Councils

The last review of Community Council Governance was in 2009 and since then there has been changes at a national level, for example the Community Empowerment (Scotland) Act 2015 meaning there is a need to formally review the Community Council Scheme of Establishment and supporting documents.

This presents a good opportunity to strengthen Community Council's ability to represent their communities and feed into Stirling Council's development of a new place based approach with communities.

The review will happen over 3 consultation phases:

### Phase 1 - 4 October - 29 November 2017

This consultation will provide the opportunity for a wide range of individuals, community councils and organisation's to share their view on how community councils function.

### Phase 2 - 7 March - 2 May 2018

This consultation will focus on the key concepts and themes from Phase 1.

### Phase 3 - 4 July - 1 August 2018

This final phase will be a detailed consultation on amendments to the Community Council Scheme of Establishment and the supporting documents.

The intention is to hold full Community Council Elections in September 2018.

## Consultation on Free Bus Travel for Older and Disabled People and Modern Apprentices Closes 17 Nov 2017.

The Scottish Government is launching this Consultation to seek your views on the concessionary travel scheme for older and disabled people ("the Scheme").

This popular and valued scheme improves access for older and disabled people to essential services and opens up participation in family and other social activities that would otherwise not be affordable, ultimately offering independence to people who rely on bus travel.

Whatever happens going forward, if you already have a bus pass, or obtain one before any changes are made, you will not lose it! Those with a bus pass will continue to access the benefits of the Scheme. In addition we will not be making any adverse changes to the existing eligibility criteria for those with a disability.

## Social Enterprise Action Plan 2017 - 2020

The Scottish Government has announced 92 commitments in its [2017-2020 Social Enterprise Action Plan](#). The plan follows publication of Scotland's first [Social Enterprise Strategy](#), aimed at sustainably growing the sector over the next decade. Actions include increased backing – £1m each year for the next three years – for the Social Entrepreneurs Fund, which offers grants and business support to help people to make their start-up aspirations a reality; a Buy Social certification scheme so consumers know when they are buying from a social enterprise; and social enterprise classes in schools.

## Life for people in Scotland in 2016

The proportion of households in the private rented sector continues to grow. Over half of adults view climate change as an immediate and urgent problem and more households are now disposing of their food waste in local authority-provided food caddies. Recreational walking has risen and continues to be the most common type of physical activity. There are high and increasing levels of cultural participation in Scotland.

These are just some of the findings from the wide-ranging [2016 Scottish Household Survey](#). The survey has been designed to provide reliable and up-to-date information on the composition, characteristics, attitudes and behaviour of Scottish households and individuals since 1999.

## Youth Can Do It campaign

The Prince's Trust has reinforced their faith in the nation's young people with a new campaign called Youth Can Do It, which sends an empowering message to the UK's young people.

This new campaign champions the resilience and potential of young people, in the wake of new research which shows young people's confidence is suffering – with one in five 11 to 19-year-olds believing they will amount to nothing, one in four thinking people do not believe in them, and almost half thinking they will struggle to find employment after they have finished studying

## Events Funding

Funding is available from Stirling Council Events Funding / Community Grants / Community Pride – grants up to £1500 available:

There is one more deadline before Christmas for Stirling Council's small grants. **This next deadline is noon on 8 November** with a decision on 13 December – remember your project cannot start before the decision date.

This year we had an extra allocation of funding towards community events, and there is still a limited amount remaining in this programme. **So if you are planning any kind of community event for Christmas or New Year now is your last chance to get your application in and bring the community together for some fun and celebration at this time of year.**

All our programmes share an application form and all have money remaining within them, so whatever your project is, community event or otherwise, send your applications in and we will sort out at this end under which programme it could be considered. They are very flexible grants programmes which will fund a wide range of projects; we will consider all sorts of things if you can demonstrate how they benefit your community (please note however, we do not fund on-going day to day core running costs of an organisation).

## Ideas, Innovation, Improvement Grant

The Clackmannanshire and Stirling Health and Social Care Partnership have allocated money from the Integrated Care Fund (ICF) for one-off grants to support the development of new or existing third sector initiatives which build capacity within communities in order to encourage health and wellbeing.

The fund aims to award grants to community based activities that support adults to maintain or improve their health and wellbeing. The fund also seeks to fund activities that increase the ability of community based organisations to provide a service to local people. Communities may be geographical or communities of interest.

Applications for amounts up to a maximum of £2,000 for an individual organisation or up to £6,000 for organisations applying in partnership will be considered. Partnership applications must clearly demonstrate the benefit of the partnership.

## Year of Young People 2018 - Youth Community Action Fund

The Year of Young People 2018 aims to inspire Scotland through its young people, celebrating their achievements, valuing their contribution to communities and creating new opportunities for them to shine locally, nationally and globally.

This new fund has been created to provide opportunities for local groups working with young people to facilitate informal education and learning opportunities that support this aim.

Proposals must:

- Engage young people aged 8 – 26 years.
- Be co-designed with local young people to ensure they are fully involved in the development, management and delivery of the proposed activity.
- Promote equality and be open and accessible to young people.
- Demonstrate sustainability (whether in attracting other resources or in leaving a legacy).

The fund will consider applications from the following bodies:

- Constituted groups and organisations from the voluntary youth work sector.
- Local Authority Youth and/or Community Learning Services.
- Organisation working in partnership with a local youth work provider.

Maximum Award £2,000.

**All proposed activities must be delivered between 1 January 2018 and 31 December 2018.**
