### Community Planning in Stirling and the development of a Local Outcomes Improvement Plan (LOIP)

Community Planning is the term used to describe how public services work together with local communities and third sector organisations to plan and deliver services that will improve quality of life and tackle inequalities. It is based on the principle that by working together, we can achieve much more than we would trying to do things on our own and collectively we can resolve complex and deep rooted inequalities in our communities.

Community planning is not new and there has been a Community Planning Partnership operating in Stirling for 20 years. However, a new Act called the Community Empowerment (Scotland) Act 2015 has made amendments to community planning and it is now a statutory requirement for a number of public sector bodies to participate in the community planning process. The Act has also placed a duty on 5 public sector bodies to own and lead the community planning process. The 5 key partners are Stirling Council, NHS Forth Valley, Police Scotland, Scottish Fire and Rescue and Scottish Enterprise.

The Community Empowerment Act clarifies the purpose of community planning. In a nutshell, community planning is now about how public bodies work better together, and with local communities, to plan for, resource and provide services that improve local outcomes and reduce inequalities.

Community Planning Partnerships have a statutory duty to prepare and publish a 10 year strategic plan setting out the high level outcomes they want to achieve and their partnership approach to making this happen. This high level plan is called a Local Outcomes Improvement Plan (LOIP) and will be underpinned by detailed Locality Action Plans for our most disadvantaged communities.

The LOIP must be developed from a strong foundation of understanding of our area. In Stirling, data and evidence has been captured from national, regional and local sources to provide an understanding of the differing levels of need an inequality across Stirling. Community planning partners have also worked in conjunction with a community sounding board and third sector representatives to develop the LOIP.

A consultative draft LOIP is now prepared and a series of engagement events are being planned for January 2018. An on-line consultation will also be launched early in the New Year. Further details on LOIP engagement and consultation will be available in the next edition of this newssheet.

### **Review of Scheme of Establishment of Community Councils**

The first phase of the review closed at the end of November, we want to thank everybody that contributed to the survey and to those Community Councillors who attended the Community Council conference at the end of November.

There was over 399 responses to the survey with a wide range of contributors from individuals, community councillors to elected members and Stirling Council Officers.

On Saturday 25 November 2017, community councillors came together to receive feedback on the online survey and to discuss the key themes of governance, boundaries, representation, communication and resources.

This information will inform proposed and improvements to the amendments to the Scheme of Establishment for Community Councils. This will be presented during the 2<sup>nd</sup> Phase Consultation starting in March 2018.

### **Rural Transport**

Stirling Council is stepping in to help residents in rural locations who have been cut off by a lack of transport options with a range of new measures. The rural communities of Drymen, Buchlyvie, Callander and Killin were identified as areas to target as part of a transport review using census data looking at key demographics and current transport links.

Before agreeing which solution(s) to implement a community survey was carried out to identify the transport needs of these community and confirm the main transport gaps. An online survey was live between 30 June 2017 and 31 August 2017 with in total 531 respondents across the council area in addition to feedback from local consultation events within the communities.

The £140,000 project includes a new shopping bus service and a social bus service to rural areas, an online transport booking service, and a youth scheme to help school pupils develop their own ideas to improve accessibility to rural areas.

The funding will also help develop a new improved Demand Responsive Transport (DRT) online booking service, which will allow users to manage their own bookings, make same day bookings, and receive text alerts confirming the DRT operator, phone number and fare.

Pupils from Balfron and McLaren High Schools, working in conjunction with Young Scot, will also be given the opportunity to develop their own ideas to overcome transport barriers in rural Stirling via a Youth Innovation Solution project.

### Online benefits and employment advice platform

Stirling Council has launched the **Better Off platform** which will seek to significantly improve the way customers access benefits and employment advice. The web-platform, will show people the benefits they are entitled to and will provide help to apply for them online. Better Off also provides information on how to find and apply for jobs.

The web platform, accessed from the Council's website, will offer secure and confidential access with Libraries across the Stirling region offering access to the platform.

Our aim is to put money in people's pockets faster. The tools include:

- An income maximisation calculator, enabling customers to find out what benefits they are entitled to.
- Applications and appeals, to apply for a benefit or appeal a benefit decision.
- Employment advice, search for jobs and volunteering opportunities and record your job search activity.
- Advice on finding jobs, childcare, budgeting and debt issues.

### Stirling Libraries rolls out "Every Child a Library Member" to local nurseries

A project to make sure every child in Scotland has access to the library is now being rolled out to nurseries across the Stirling area – with children benefitting from online access and no fines. Using their new library cards, children can borrow books and enjoy free comic books and e-books online.

The national project, titled "Every Child a Library Member" is funded by the Scottish Government and aims to encourage more children to use their local library. The rollout of the Every Child a Library Member scheme will reach nurseries across the Stirling area over the next year.

### **Buchlyvie Play Park upgrade**

Buchlyvie Community Association upgrade their play park in Buchlyvie and enabled the Primary School to be the first school in Scotland and the first primary school ever to secure NIBAS (National Indoor Bouldering Award Scheme) Level 1 and 2 Accreditation. Bouldering is a form of climbing usually practiced on small rock boulders, or at indoor walls.

Parent volunteer and course director, Mark Henley-King says "We've been running a bouldering after-school club using the Buchlyvie boulder since 2015. I'm thrilled that we can offer this



formal accreditation programme to young people in Buchlyvie. We have eight young aspiring climbers who are now registered with NIBAS and are working towards their Level 1 Award."

The Buchlyvie boulders are located in the village's play park making it an open access play facility. The views from the top of the big boulder are spectacular. The boulders were designed and built by the artificial climbing wall specialists, Rockworks. "This project has been a great example of collaboration," says Anne Winther, Chair of Buchlyvie Community Association. "We couldn't have done it without the help of Mountaineering Scotland and Active Stirling who helped us select the boulder design.

The project to redevelop the Buchlyvie Play Park over the last eight years was managed by Buchlyvie Community Association (A Scottish Charitable Incorporated Organisation SC043330), who have worked in partnership with Stirling Council's Land Services and Community Engagement Team.

### **Local Bus Services in Scotland – Improving the Framework for Delivery**

The Scottish Government are consulting on the legislative framework governing bus services which they consider can be improved to make it more flexible and viable, whether a transport authority wishes to pursue partnership working, local franchising or even running their own buses.

### A healthier future - action and ambitions on diet, activity and healthy weight

This consultation document proposes a range of actions to improve diet and weight in Scotland. In launching the consultation, the Government announced funding of £42 million over the next 5 years to expand services. Other proposals include: action on junk food advertising; preventative services including information, advice and support for children and families on healthy eating; practical support for food manufacturers to reformulate and develop healthier products.

### **Empowering Schools: A consultation on the provisions of the Education** (Scotland) Bill

The Education (Scotland) Bill is to create a school and teacher-led education system. The Bill will establish a Headteachers' Charter and aims to improve parental and community engagement in school life and in learning outside of school, and strengthen the voice of children and young people, by actively promoting and supporting pupil participation.

The Bill will also enable registration of other educational professionals with the Education Workforce Council, taking on the responsibilities of the GTCS and Community Learning and Development Standards Council. This will establish professional standards for other education professionals within the workforce.

### **New Data Protection**

As you may be aware, the General Data Protection Regulation (GDPR) replaces the current Data Protection Act and comes into force on 25 May 2018. Regulated by the Information Commissioner's Office (ICO), the GDPR strengthens the rules around personal data and requires organisations to be more accountable and transparent. It also gives people greater control over their own personal data.

Like the Data Protection Act, the GDPR applies to 'personal data'. However, the GDPR's definition is more detailed and makes it clear that information such as an online identifier – eg an IP address – can be personal data. The more expansive definition reflects changes in technology and the new ways organisations collect information about people.

For most organisations it should make little practical difference if they already comply with data protection. However the ICO have information on their website and have launched a dedicated advice line on to help small organisations and charities prepare for a new data protection law. The GDPR applies to all EU member states but gives them limited opportunities to make provisions for how it applies in their country. This has meant the British Government has created a Data Protection Bill which is currently going through parliament and covers aspects like national security, immigration and the role of the ICO which is not in the GDPR.
