5) Projects

The final version of the Local Place Plan is being drafted which includes additional descriptive text and couple of comments from the consultation period. It will be finished within the next couple of weeks and sent to Stirling Council. A digital version will be available at https://balfroncc.org.uk/local-place-plan/. There will be a hard copy available at the Library, High School and with the Community Council. Stirling Council are hosting public sessions to consult on the Local Development Plan and there is one in Balfron Library on 26 June.

6) Police Report

Anti-social behaviour

A person was arrested, charged and held for custody for threatening and abusive behaviour and thereafter resisting arrest.

Fraud

A resident has been defrauded out of a large sum of money after making contact with what they believed to be an online investment company.

Another resident has been a victim of fraud after they were contacted by telephone from someone purporting to be from their bank. The suspect advised them there had been suspicious activity on their account and to tell them the 4 digit security code they received to their phone. Unfortunately, two fraudulent withdrawals were made before the victim realised it was a scam.

Last year, the community policing team organised and ran a talk at the bowling club to discuss the dangers of fraud. PC McCammon has suggested running a similar session again; BCC support and welcome this suggestion.

7) Elected Councillor's report

Cllr Henke will continue to chase an update on any proposed developments at the site of Strathendrick Care Home.

8) Treasurer report

The weekly delivery of fruit and vegetables will cease at the end of this month and be reinstated at the next payment date (October) for the grant.

9) Planning report

The application to fell 1no. Scot's Pine and 1no. Cherry Birch Ossian 1A Cotton Street Balfron G63 0TD was discussed. Comment to be returned on this application suggesting pruning rather than felling.

Discussed the Shelloch Wind Farm, Fintry. Although Balfron does not have visibility of the development, the students of the communities who will receive the community benefit funding attend Balfron High School. Craig will investigate the details of the development's community benefit funding.

This was discussed and agreed as an interesting proposal that could be extended elsewhere in the village and both proposals would be dependent on securing external funding. The poor quality of the road surface at Printers Row was brought to our attention and the matter raised with Stirling Council.
